Sub:-Recognition certificate for the school under sub-rule (4) of rule 11 of Right of Children to Free and Compulsory Education rules, 2011 for the purpose of section 18 of Right of children to Free and Compulsory Education act,2009.

Respected sir /madam,

With reference to your application dated 11.10.2021 and subsequent correspondence with the school /inspection in this regard ,I convey the grant of provisional recognition, U K PUBLIC SCHOOL Tal: Dapoli, Dist:-Ratnagiri operated by Darul Falah Educational And Welfare Trust for the class 1st to 8th for a period 2021-22 to 2023-24.

The above sanction is subject to the fulfillment of the following condition namely:-

1. The grant for recognition is not extendable and does not in any imply any obligation to recognize/affiliate beyond class VIII.
2. The school shall abide by the provision of the Right of Children to Free and Compulsory Education Act 2009(Annexure I) and the Right of Children to Free and Compulsory Education rules, 2011(Annexure II).
3. The school shall admit in Class I , to the extent of 25% of the strength of that class, Children belonging to the weaker section and the disadvantaged group in the neighborhood and provide free and Compulsory Elementary education till Its completion.
4. for the children referred to in paragraph 3, the school shall be reimbursed as per sub-section 2 of section 12 of the Act. To receive such reimbursement ,the school shall provide a separate bank account.
5. The school shall not collect any capitation fee and subject the child or his or her parents or guardians to any screening procedure.
6. The school shall not deny admission to any child for lack of age proof or if such admission is sought subsequent to the extended period prescribed period prescribed for admission or on the ground of religion ,caste or race ,place of birth or any of these reasons.
7. The school shall ensure that:-
 - a) no child admitted ,shall be held back in any class or expelled from school till the completion of elementary education in school.

- b) no child shall be subjected to physical punishment or mental harassment.
- c) no child is required to pass any board examination till the completion of elementary education.
- d) every child completing elementary education shall be awarded a certificate as laid down under rule 23;
- e) inclusion of students with disabilities/special needs as per the provision of the Act.
- f) the teacher are recruited with minimum qualifications, as laid down under sub-section (1) of section 23; provided that the existing teachers who, at the time of commencement of the Act, do not possess the minimum qualifications, shall acquire such qualification with a period of 5 years from the date of commencement of the Act.
- g) the teacher perform their duties, specified under sub-section (1) of section 24 of the Act and;
- h) the teachers shall not engage himself or herself in any private teaching activities.

8. The school shall follow the syllabus on the basis of curriculum laid down by appropriate authority.

9. The school shall enroll students proportionate to the norms and standards available in the school as specified in section 19 of the Act.

10. The school shall maintain the standards and norms of the school as specified in section 19 of the Act. The facilities reported at the time of last inspection, if made, are as given under:-

- Area of school Campus:- 4000sq.m
- Total built up area:- 970 sq.m
- Area of playground:- 2350sq.m
- No. Of classrooms:-10
- No.of rooms for headmaster-cum-officer-cum-storeroom:-02
- Separate toilet for boys and girls:- yes, it is there.
- Drinking water facility:- yes, it is there.
- Kitchen for cooking Mid-Day-Meal:- yes
- Availability of teaching learning material/play sports equipments :-yes, it is there.
- Library:- Yes, it is there

11. No un-recognized classes should be run within the premises of the school or outside of the premises in the same name of school.

12. The school buildings or other structure or the ground shall be used only for the purpose of education and skill development.

13. The school is run by a society registered under the societies registration Act, 1860 (Act no. 21 of 1860) or a public trust constituted under any law for the time being in force.

14. The school is not run for profit to any individual, group or association of individuals or any other persons.

15. The account should be audited and certified by a Chartered Accountant and proper account statements should be prepared as per rules. A copy of each of the statements of accounts should be sent to the District Education Officers every year.

16. The recognition code number allotted to your school will be same as U-Dise. This may please be noted and quoted for any further correspondence with the office.

17. The school furnishes such reports and information, as may be required by Director or District Education Officer from time to time and complies with such instruction of the state government/ local Authority, as may be issued to secure the continued fulfillment of the condition of recognition or the removal of deficiencies in working of the school.

18. Renewal of Registration of Society, if any, be ensured.
